## **HIGHLIGHTS**

### New Wormeries Project

Wormeries for Westbury

Grant from Neighbourhood Partnership, volunteer wormières have been recruited. We have distributed 4 wormeries. This is included in the Good Food Plan for Bristol. Another 14 wormeries are on order paid for by the grant. There are 2 types of wormery. No other group in Food Network is promoting wormeries or even general composting initiatives.

It was suggested that we have a slug and worm meeting to promote wormeries and invite Julian Lea-Jones to give his presentation on anti-slug defence strategies.

### Bristol Green Capital 2015

Not represented on a list of organisations involved. We need to pledge to do something. Some organisations have received funds. This could be based around the wormery project via the food network. There is a newsletter and there will be extra focus on next year's Big Green Week.

We should pursue connection with this.

Did not get a NP grant to negotiate with landlord of Carlton Court. Justine of the cake stall may be interested in management of the market. Carry on until at least May when the bike people are coming. Cheese stall is finishing. Problems are location, regularity, outdoors.

This could have knock on consequences for SusWoT sales of apple juice, plants and seeds and other products.
